## HON. TREASURER'S REPORT ON THE RECEIPTS AND PAYMENTS ACCOUNTS for the year ended 31 December 2018

#### FINANCIAL HIGHLIGHTS

- 1. Cash available at 31 December 2018 finished at £32,996 compared with £21,781 at 31 December 2017, an increase of £11,215 or 51%. There are two main reasons for this increase in cash a sharp fall in General Fund payments (down by £6,417) and a sharp increase in Appeal receipts (up by £6,242). More details are set out below.
- 2. <u>General Fund payments</u> In 2018 General Fund payments fell substantially from £16,455 in 2017 to £10,038, a decrease of £6,417 or 39%. There were four main reasons for this sharp decrease:
  - a. IT and web site expenditure In 2018 this fell to £348 compared with £1,063 in 2017 when the Committee approved extra expenditure to refurbish the web site.
  - b. Expenditure on Events In 2018 this fell to £860 compared with £2.221 in 2017 when the Committee approved extra expenditure to replace display stands and banners for use on Chestnut Sunday and other events.
  - c. Other costs In 2018 this was nil compared to £300 Other Costs in 2017. A single fraudulent payment of £300 was made in March 2017 as a result of a bogus Standing Order being set up. The NatWest Fraud Unit cancelled the Standing Order and reimbursed the account with £300 in 2017.
  - d. Stoup basin hoods in the BP Water Gardens This project was completed in 2017 with expenditure of £4,620. In 2018 The Royal Parks donated £1,500 to the costs of the project (see 2018 General Fund Receipts).

#### 3. Appeals -

- a. The Appeal launched in Autumn 2018 for the new Information Point had raised £4,496 in donations by the end of 2018 with initial project expenditure of £616.
- b. We spent £2,361 in 2018 on other Appeals projects, mainly for planting work and for a new SHAEF flag pole in Bushy Park. Our usual income sources to fund Appeals projects continued to be merchandise sales of £5,143, members' donations and bucket collections. Merchandise sales were buoyed by good sales of calendars, cards and leaflets whilst honey sales were slightly down. The Donations Box at the Information Point continued to be successful with money collected in 2018 of £897 (including £289 from Chestnut Sunday) which will go towards the new IP Appeal.
- 4. There is no need to increase annual subscriptions at this AGM but the Trustees will continue to review the matter. The report of the Hon. Auditor is overleaf.
